The legislative branch FY2013 budget request of \$4.512 billion, which is submitted to the President by the legislative branch agencies and entities and included in the budget without change, was submitted to Congress on February 13, 2012. The request represents an increase of \$205.5 million over the \$4.307 billion in discretionary funding provided in Division G of the FY2012 Consolidated Appropriations Act (H.R. 2055, P.L. 112-74), which was enacted on December 23, 2011. The Subcommittees on the Legislative Branch of the House and Senate Appropriations Committees both held hearings during which Members considered the FY2013 legislative branch requests. Among issues that were considered during hearings were the following: the tight budget environment, prioritization of budget resources, and further options for potential savings or efficiencies; state and district office security; preparations and funding...
